Cultures in Conflict/Conflicting Cultures

November 9-10, 2012, University of Zurich

The Department of American Studies of the University of Innsbruck organized the 39th international conference of the AAAS in cooperation with the SANAS (Swiss Association for North American Studies), which took place on November 9 and 10 at the English Seminar of the University of Zurich.

The conference was opened by Prof. Elisabeth Bronfen, followed by the first keynote lecture on crises of intelligibility by Prof. Jonathan Lear (University of Chicago). The other two keynotes were delivered by Prof. Barbara Klinger (Indiana University) and Isabel Gil (Catholic University of Portugal) and focused on Hollywood classics in an intermediated world and cultural theory, respectively. The theoretical and thematic foundation created by these contributions made for interesting interdisciplinary debates on both days of the conference. The 21 papers presented at the conference dealt with a wide variety of topics ranging from the reflection of the Iraq War in the media to conflicting narrative authorities and rival identities in film and literature. Despite this thematic richness, the overarching topic of the conference – conflict in its cultural, medial, or political manifestation – remained at the heart of all presentations.

The conference was well attended by students and scholars from Switzerland, Austria, Germany, and the United States, and both AAAS and SANAS were praised for the smooth organization of the event. The successful cooperation with our Swiss colleagues thus resumed a fruitful tradition that will be continued in the future.

4. FULBRIGHT PRIZE 2012

Laudatio by Univ.-Prof. Mag. Dr. Mario Klarer, University of Innsbruck

MMag. Dr. Cornelia Klecker (*Spoiler Alert! Mind-Tricking Narratives in Contemporary Hollywood Film*) and Mag. Dr. Johannes Mahlknecht (*Paratexts in Narrative Cinema*)

As the president of the Austrian Association for American Studies it is a great pity for me not to be able to attend this year's joint conference with the Swiss Association for North American studies in Zurich. I regret this because, as one of its organizers, I would have loved to be present at the conference. And I would like to thank Ralph Poole for stepping in as Vice President of the AAAS. However, what makes it particularly hard not to be present is that I am not able to award the Fulbright Prize in American studies in person this year. The reason why this is such a pity for me is that two of my PhD students are the winners of this year's prize. It is a great honor for a dissertation advisor to have one prizewinner, let alone two.

I have asked my colleague Christian Quendler to read my laudation. Knowing both prize-winners, who started their careers in our FWF project which Christian Quendler was so instrumental in securing for the department, and also sharing their research interests, Christian is the ideal person to perform this ceremony. I would also like to express my gratitude to the Fulbright Commission and Dr. Lonnie Johnson for their continuous support and for making this prize possible.

The two prizewinners, Cornelia Klecker and Johannes Mahlknecht, have a lot in common: both are staff members in the American Studies Department at the University of Innsbruck, both completed their dissertations last year with me, both share the same office in the northeast corner of the humanities building at the University of Innsbruck, and both wrote their dissertations on film.

Although they both worked on film, their approaches, as it seems, could not be more different: Cornelia Klecker worked on film narratology, focusing on mind-tricking narratives, that is, films with a twist ending, and Johannes Mahlknecht dealt with filmic paratexts, that is, the elements surrounding the film proper, such as posters, opening credits, trailers, or legal disclaimers.

Cornelia Klecker

Let me start with Cornelia Klecker. Already in her MA thesis, *Skip and Rewind: When Time Gets Out of Line in Mainstream Film,* which won both the Fulbright Prize and the AAUTE prize for best thesis, Cornelia dealt with issues of plot in contemporary cinema. Her dissertation, *Spoiler Alert! Mind-Tricking Narratives in Contemporary Hollywood Film,* builds on this research, but ventures

into completely new territories.

Cornelia Klecker's dissertation contributes to recent discussions of complex storytelling within the area of film narratology and film theory in general, concentrating on one specific trend in contemporary mainstream film that so far has largely been neglected. Klecker refers to this new genre of films as "mind-tricking narratives." These films employ narrative techniques that deliberately play with the viewers' experience, response, and expectations during the viewing of a film because of an utterly surprising outcome in the end. The list of films belonging to this category include M. Night Shyamalan's *The Sixth Sense*, David Fincher's *Fight Club*, and Christopher Nolan's *The Prestige*.

We all remember M. Night Shyamalan's 1999 *Sixth Sense* because of its epiphany-like ending that forced us as viewers to re-examine the plot retrospectively after the first viewing. For example, in the famous scene in which Bruce Willis meets with his wife in a restaurant on their wedding anniversary night, the climate of this wedding anniversary dinner is rather frosty. When watching this scene for the first time, we all thought that Bruce Willis was late for dinner and his wife is angry at him for having spoiled the evening by not being on time, or simply because they have little to say to each other and their marriage might be on the rocks. At the end of the film when we find out that Bruce Willis had been dead all along, that he is a ghost, we replay this scene in out minds and realize that his wife could not see or hear him because he was invisible—hence her silence. With the moment of epiphany—him being a ghost—in the back of our minds we reinterpret other major scenes of the film in a different light than before we had this insight. We have to replay crucial scenes of the movie from memory, so to speak, as well as reinterpret the entire plot based on this new insight.

For the past 15 years there has been a steady increase in films that employ these mind-tricking narratives, thus catering to the needs of the viewers' fascination for confusion as well as interest in more sophisticated storytelling. Here, Klecker challenges the dominant view of contemporary mainstream film, namely, that they adhere to the conventions of Classical Hollywood style, as described by David Bordwell, Janet Staiger, and Kristin Thompson in their *The Classical Hollywood Cinema*. According to these scholars the Hollywood style is characterized by a clear and comprehensible narrative flow which completely disguises the film's artifice. Mind-tricking narratives, on the other hand, offer a meticulously designed distribution of information and break basic narrative conventions, and, in turn, provide two distinct readings of the same text.

By closely analyzing the narrative structure of a clearly defined corpus of films released between 1994 and today, Klecker establishes a taxonomy of mind-tricking narratives, identifies the most frequently used narrative tools and techniques, and examines the viewer's capacity for story comprehension with a cognitive approach. For Klecker, mind-tricking narrative is a

subcategory of what is often referred to as "complex narrative," an area of film studies, which has been discussed in recent years by Bordwell and Cameron. The focus so far has essentially been on films with "unusual" plot structures, that is, all varieties of fragmented, discontinuous, and simultaneous narratives. Klecker establishes "mind-tricking narratives" as a distinct and clearly defined new category. A core aspect of mind-tricking narratives is that they do not simply "make people think" but they deliberately deceive them. They hold back some vital information until the very end of the film. The instant this piece of information is finally revealed, the audience will experience the ultimate epiphany. However, despite their continually rising popularity since the mid-nineties, mind-tricking narratives have largely been ignored by film scholars.

Klecker, therefore, ventures into uncharted waters and thereby writes herself into a central domain of film history and film narratology. By approaching a currently dominant, but neglected, field in film studies—with her background as a trained literary scholar—she is able to provide insights into this new field from a rather unconventional vantage point. Both her theoretical grounding of this new genre of the Hollywood film in a cognitive approach, as well as her insightful and original close readings of selected films, will make the dissertation a major contribution to international film studies. Klecker's courage in attempting sociological explanations for the rise of this new genre of film in the recent past is surprising. Without falling into possible traps of oversimplification Klecker provides sound and convincing reasons for the current craze for mind-tricking narratives in popular culture. She also does not hesitate to include material from popular culture, as for example, a recent episode of *The Simpsons* to illustrate her points.

Klecker's level of sophistication is very impressive since she can hardly rely on previous research on her topic by other scholars. Having defined her area of research in a new and unprecedented way, Klecker had to design her own methodological basis without being able to draw on scholarship directly related to her research. Even for her individual case studies, which are mostly recent releases, Klecker could not work with existing interpretations of the filmic texts she discusses but had to rely mostly on her personal intuition and her expertise in film theory.

Johannes Mahlknecht

While Cornelia Klecker focuses on the main structural features of the film proper, Johannes Mahlknecht "lingers" at the periphery of film—writing, as he calls it, on or about the "edge" of films. In this highly readable and original dissertation, *Paratexts in Narrative Cinema*, Mahlknecht provides a historically informed typology of various peripheral phenomena that surround narrative cinema. Each of the dissertation's nine chapters impressively deals with one

of the major elements that together make up what he (adapting a concept by Gérard Genette) refers to as the peri- or paratexts of film: logo, motto, title, cast of characters, front and end credits, legal disclaimer, tagline, and movie novelization. By using a frame-analytical approach, Mahlknecht can rely on an ideal methodological basis for his illuminating close readings of filmic peripheral elements.

In a largely diachronic approach, Mahlknecht analyzes numerous select examples ranging from the silent film period up to the present. His main focus lies in the interface between the extradiegetic nature of the framing elements and the diegesis of the respective films in question. This interface, he explains, manifests itself in the space between producers' endeavors to *tell about the film's production history* on the one hand, and filmmakers' attempts to *tell a story* on the other. Mahlknecht investigates the conventions filmmakers have established in order to negotiate between realms that at first may seem to be mutually exclusive and points out how these conventions have changed over time.

In each chapter he eloquently discusses both the functions of paratexts and the way they are presented on the screen—in terms of typography, design, and placement—and analyzes how the presentation is used in order to facilitate a smooth transition between the nondiegetic and diegetic realms. In providing a gradation of the diegetic qualities of paratexts, he shows how words, in combination with their visual presentation, can shape the viewers' expectations as well as their attitude toward a particular film as a whole. His investigation ultimately leads to the argument that, in many cases, the more the paratext is made to merge with the diegesis of the film proper, the more it is likely to achieve its intended effect on the audience.

Mahlknecht's dissertation thus convincingly counters a claim made by André Gardies, who in his 1977 essay "Am Anfang war der Vorspann" points out the paradox that apparently exists in narrative cinema between the diegesis of the film and its opening credits. Gardies argues that while the text of a film aims to present the story in a manner as realistic and credible as possible in order to allow audiences to suspend their disbelief, the paratext makes us aware of the fictionality of the film, thus destroying the illusion filmmakers attempt to create on the screen. Mahlknecht, on the other hand, argues that the paradox between the frame of the "factual" paratext that Gardies believes destroys the illusion of the fictional text, can in fact be used in order to heighten it. In his many examples he analyzes such element as well as the various ways in which filmmakers attempt to blur the boundaries between the frame of the paratext and the text. The result is that one mingles with and thus becomes an organic part of the other.

Where Mahlknecht's dissertation most strikingly diverges from hitherto published material on the subject of peritexts in general and peritexts in *film* in particular is in its systematic typological nature, as well as in its diachronicity. He pays detailed attention to a

corpus of several dozen examples from early narrative cinema, which he then compares with examples from more recent periods in film history. His approach provides great insight into conventions and trends that were prevalent at a certain period and shows how these conventions have changed and developed over the decades. While other authors have written on paratexts in film (notably Alexander Böhnke and Vinzenz Hediger), Mahlknecht's approach is historically informed and far more thorough, thematically wide-ranging and more clearly arranged. His methodology thus breaks new ground for future research about peripheral phenomena in film and thereby easily surpasses the standard requirements for a dissertation.

Having pointed out the differing approaches of the two prizewinners, I think it is now time to go one step further and highlight the fact that, on a structural level, both prizewinners share a lot of common ground. Cornelia Klecker, as I said, is interested in how we retrospectively reconstruct the story of a film. She looks at all of the mechanisms at work when viewers try to make sense of data with a new horizon of knowledge at the very *end* of a film. Johannes Mahlknecht traces something similar, but starts at the opposite end, namely, the very *beginning* of a film, in some cases, as in posters or trailers, even *before* the beginning of the film. While Cornelia is concerned with retrospection, Johannes indulges in anticipation, delayed pleasure, if you will. Paratexts shape our anticipation of a film, or make us "project" the film in our imaginations before actually viewing the film. Posters, taglines, trailers, casts of characters, tie-in products, and novelizations all make us imagine the movie in one way or another, including genre, plotline, cinematography, or acting. So, both dissertations in a way concern themselves with virtual cinema, in the sense that they are interested in cognitive aspects of film viewing, or more precisely, film *imagining*—whether it is retrospection, as in Cornelia's case, or through anticipation in Johannes's case.

There are, of course, other similarities between the two. They are good friends, and seem to have a lot of things to laugh about together, sharing the reputation of being excellent teachers and most reliable colleagues. They also support each others excellent scholarly work in a number of ways, attending conferences together, as well as setting a high bar for each other when it comes to publishing in top theory journals. For example, both have published essays in *Poetics Today*, as well as other leading journals in the field.

All of these reasons—the huge relevance of their topics for contemporary popular and high culture, coupled with original methodology, and a style that is virtually indistinguishable from a gifted native speaker of English—make the two dissertations potential future standard works in interdisciplinary film studies. Given the fact that large parts of the dissertations have been published in leading international journals, I am not only convinced that their research will become a major voice in international scholarship, but rather that it is a major voice already. The

dissertations are so well written and readable in their current state that I could see them published with major presses as they are without any revisions.

Being able to award this year's Fulbright Prize to Cornelia and Johannes in my function as their dissertation advisor should make me very proud. But what only *I* can know is that both of them could have done just as well without an advisor. I have hardly ever seen two young scholars so independent in their endeavors and ideas—so that I felt more like a privileged observer than a director or advisor. On the contrary, I felt, and continue to feel, advised by their expertise, which both of them continue to share with me and everybody else in the department.

For all of these reasons I am thrilled that this year's Fulbright Prize in American Studies goes to Cornelia Klecker and Johannes Mahlknecht.

The Austrian-American Educational Commission (Fulbright Commission) is pleased to announce that it will grant an annual award of € 1.000 for the best thesis in American studies. This award is based on an annual competition managed by the Austrian Association for American Studies. The Fulbright Prize is a means of acknowledging the enduring importance of American Studies and the role of innovative research by young Austrian scholars in contributing to the fulfillment of the Fulbright Program's mandate to promote mutual understanding between the peoples of Austria and the United States of America. The purpose of this award is to recognize superior academic achievement in the field of American Studies (Amerikanistik) in the broadest sense of the word and hence includes all relevant ancillary disciplines and departments at Austrian universities (e.g., comparative literature, history, political science, sociology, etc.) There are no specific topical or methodological limitations on submissions. Advisors of students completing a traditional thesis (Magister), a Master's thesis in the new Bologna curricular regime, or a doctoral thesis in relevant disciplines at Austrian universities in the course of the 2012-2013 academic year are encouraged to nominate distinctive work of their students for review.

Nominations for this award consisting of a cover letter from the thesis advisor and a copy of the thesis (as .pdf-document, max 2 MB) should be sent to

The deadline for submissions is May 1, 2013.

A committee will review applications, have the work of semi-finalists subject to external review, and nominate a finalist. The winner of the Fulbright Prize in American Studies 2013 will be announced at the next AAAS meeting.

AAAS Conference 2013 (40th International Conference): "American Utopias" Schloss Leopoldskron in Salzburg, November 8-10, 2013 Organized by the Department of English and American Studies, University of Salzburg

The 40-year-anniversary AAAS conference takes occasion to look back to early American colonial endeavors of the Puritans who viewed the New World as a place to create a New Canaan, to revisit the utopian communities of the 19th century, to look ahead to visions of ecological and economic future worlds. From the start, American utopias have been eminently political, be it as religious diaspora or socialist experiment; and yet, their agendas have just as prominently been articulated via texts. Conceiving of alternate systems (real *or* imaginary) necessarily involves meditating on difference and otherness in varying degrees of radicalness. Whether fantastic or realist, successful or failed, utopian or dystopian, such imaginations deal with spiritual crises of some sort that need to be taken into account when assessing their narrative content as well as their representational strategies.

Questions that may be raised are: Why have utopias thrived in one period and disappeared in others? What solutions do utopias offer to the dilemma of positing the end of history and envisioning a better future? What is the relation of utopian narratives to science fiction? How has the shift in utopias from space to time affected the relation between individual and collective time, esp. regarding the experience of everyday life as quintessential sign of utopian representation (Roland Barthes). Are utopias emblematic for the fateful separation of art and culture from the social, as Herbert Marcuse has suggested, or are we still governed by an overarching utopian impulse that Ernst Bloch has famously called the *Principle of Hope?* Is the concept of utopia still meaningful, as Fredric Jameson has recently and forcefully asked, and does America's future still hold promises for a 'perfect society' that does not (yet) exist?

Possible areas of investigation include, but are not limited to:

Academic Disciplines: Utopian Studies as a recent disciplinary field, but also e.g. Comparative Literature Studies as a utopian discipline (Spivak).

Economy and Politics: New Harmony (Owen/Bentham), community utopia (based on Fourier), socialist/scientific utopia (Engels), utopia as political practice, commercial pipedreams, etc.

Science and Technology: From Edison's electric bulb, Bauhaus, Futurism, to space travelling, cloning, artificial intelligence, bioengineering, etc.

Environment and Ecology: Rachel Carson's *Silent Spring* is currently celebrating its 50th anniversary. Her warnings have long been ignored, but environmental realities like global warming have caught up and are reflected in various forms such as creative non-fictions (Gretel Ehrlich) and ecotopias (Jan Hollm).

Utopian Communities: From Shakers, Owenites, Amish, Oneida, Hutterites, Brook Farm, Fruitlands, to Equity Colony, Pullman, Farm Eco-Village, Arden, Freeland, East Wind.

Gender and Sexuality: Feminist utopias/dystopias (Gilman, Le Guin, Russ, Atwood, etc.); cyborgs, gender-fluid, genderqueer, trans-fusion, post-gender.

Literature: Edward Bellamy's *Looking Backward* certainly set the standard for the utopian novel (not only, but especially for the American context), but since the mid-twentieth century envisioning futurist societies has rather often led to dark, dystopian fictions depicting repressive social control systems (e.g. Skinner); utopian and dystopian texts in their historical and literary contexts; intertextuality; allegory.

Media: Film (*The Beach, Blade Runner, 12 Monkeys, The Matrix, The Day After Tomorrow, Avatar, etc.*); television (e.g. *The Twilight Zone, Dollhouse, Aeon Flux, Dark Angel, Jericho, Star Trek, Stargate SGI, Battlestar Galactica, Twin Peaks, The X-Files, Heroes, Lost, Dante's Cove*); music (Pink Floyd, David Bowie, Fear Factory, Metallica, My Chemical Romance, Iron Maiden, Frank Zappa, Eric Clapton, etc.); games (e.g. *Fallout, BioShock, Deus Ex, Half-Life 2, Crackdown*).
